## Ottawa Journal: accomplishments for all Canadians

The spring sitting of the House of Commons has been productive. Focused on jobs and growth, keeping taxes low and protecting Canadians, our Government is proud of the results we have delivered for all Canadians.

Our Government's legislative accomplishments include the passage of Economic Action Plan 2015 (EAP 2015), a low-tax plan for jobs and growth. Through EAP 2015, we are delivering our Family Tax Cuts and Benefits Plan that is putting money back into the pockets of every single Canadian family with children. This is money that parents can spend on their family's priorities. It also takes steps to cut taxes for small businesses, invest in public infrastructure, support seniors, invest in education and skills training, and much more. And, of course, EAP 2015 is ? as promised ? a balanced budget that will help keep Canada on track for long-term prosperity.

We also passed the Anti-Terrorism Act, 2015, helping better protect Canadians from the evolving threat of jihadi terrorism. Indeed, this legislation is providing law enforcement and national security agencies the necessary tools to prevent and detect national security threats.
